# 2. Graduate Profile and Learning Objectives

The learning objectives of the study programme such as student's abilities at the time of completion of the programme and the main learning outcomes

The graduate of the doctoral study program Philosophy is ready to use the acquired knowledge and skills in several, especially scientifically and research-oriented work sectors according to the level of SKKR 8 of the national qualifications framework, which requires capabilities to manage teams, work independently, bring innovative solutions, critical approaches and erudition, design and the application of new methods. The graduate of the doctoral study program Philosophy can independently bring new knowledge to the main topics of the core of the field of philosophy: he/she proposes new methods of working with historical materials, creates original links between historical and contemporary concepts in philosophical thinking, can lead teams (especially in research communities and the scientific community), in which he/she emphasizes the role of logical and critical thinking, ethical attitudes, aesthetics, and science. He/she is also actively involved in civic life in a democratic society, in which he/she acts as a creator of new ideas to improve social life in both national and global contexts. At the same time, he/she can enrich social discourse with intellectual stimuli. The main learning outcomes of the study program include the following knowledge, skills, and competencies of the graduate who can:

## Knowledge

- choose and specify with a high degree of erudition the primary areas for the professional activity in which he/she is engaged
- consistently use the methodological tools of the field of study in his/her work and activities
- investigate projects with a comprehensive knowledge of the issue and intellectual frameworks both in terms of their history and the current state of their development
- bring innovative and original ways of solving problems, professionally conceptualize and communicate them

#### Skills

- formulate new hypotheses and adequately verify them
- design and implement strategies, action plans, and improvements in his/her field of study or in other work in which he/she is involved

- argue critically and be open to discussing the issues of his/her discipline
- creatively design projects, text materials, and presentations

- provide interpretation keys with a sense of detail as well as extensive knowledge of contexts

## 4. Structure and Content of the Study Programme

The rules for the design of study plans within the study programme

The study plan generally states

The study plan in the doctoral study program Philosophy was formed based on the valid Study Regulations of the Faculty of Arts of Trnava University (approved by the Academic Senate of the Faculty of Arts of Trnava University on November 21, 2018, and the Academic Senate of Trnava University on November 29, 2018). Each doctoral study program "aims to acquire knowledge based on the current state of scientific knowledge and in particular on the doctoral student's contribution to it, which is the result of scientific research and independent creative activity in the given scientific field". When creating the study plan, we also followed the Standards created by the Slovak Accreditation Agency for Higher Education, we took into account the statements of employers' representatives and new trends in the field, as well as the Rules for creating, adjusting, approving, and evaluating the quality of study programs at Trnava University. The present study program is developed in accordance with the mission of Trnava University. The Long-term Prospect of Trnava University, which is a basic strategic material of the university, states that the mission of the university is to create and disseminate knowledge that develops the quality of life and culture of society, which is reflected in the proposed modifications of the study program Philosophy. The submitted Recommended study plan is attached to the application for accreditation and is also available on the website of the Faculty of Arts of Trnava University.

### Importance of profile courses

The basic profile of a student at the doctoral level of philosophy studies is primarily based on the topic of his dissertation, determined by the supervisor and approved by the Field of Study Council of the Faculty of Arts. The topic of the dissertation is related to the scientific-research focus of the supervisor, who thus ensures its supervision. However, within the Recommended study plan for these studies, those courses are defined as profile courses, which refer to the main topics of the core of the study field of Philosophy and in the context of which the doctoral student prepares his/her dissertation.

The subject Continental Philosophy (P. Šajda) focuses on current research in the field of philosophical thinking, which extends beyond the European context, and deals with issues of generativity of thinking and overcoming its crises, identification of its discrepancies and transformations. In principle, it is a return to the origin of thinking in its authenticity, an active relationship to tradition, and a fruitful discussion with the analytic branch of philosophy.

In the context of the course Philosophy and Methodology of Science (T. Hauer), the doctoral student is directly involved in scientific practice, applies the methods of scientific thinking in his/her research, determines goals and concepts that are key to the elaboration of the dissertation.

The course of Existential Psychology (M. Petkanič) uses confrontation with selected theoretical concepts to develop one's thinking about personality, freedom, and responsibility. In the course Philosophy of Transcendence (P. Šajda) the student deals with new analyses of immanence and transcendence, intersubjectivity, and dialogue.

Within Historical Epistemology (A. Vydra), the student participates in the current discussion on research of the history of science and scientific disciplines, with special emphasis on the thematic focus of the dissertation. The course Problems of Contemporary Anthropology (J. Vydrová) confronts the doctoral student with the issue of the relations between the human, the inhuman, and the non-human. The current discourse on technological possibilities, dilemmas, and risks is the subject matter of the course Ethical Consequences of New Technologies (T. Hauer).

#### Overall course scheme

The structure of the submitted Recommended study plan for the doctoral degree in philosophy is composed in such a way as to help the doctoral student achieve the declared educational outcomes as well as his/her research goals. The doctoral studies develop three basic areas on the part of the student: scientific, publishing, and pedagogical.

The primary goal of the doctoral studies is the submission and successful defense of the dissertation, to which the individual study sections lead. The studies presuppose a high level of work with relevant and current sources as well as with the current state of research in the area covered in the dissertation. Participation in scientific activities in the given field of study is necessary (through grant schemes, conferences, internships and mobility).

Within the doctoral student's publishing activities, correct and independent work with textual material, bibliographic references, and preparation of relevant publication outputs in important scientific journals is expected. The doctoral student also gains experience in expertise and referee activities. The Recommended study plan pays special attention to the preparation of the dissertation project, in which the doctoral student demonstrates how he/she has progressed in the development of his/her dissertation.

The third area of doctoral studies is the pedagogical activity of the doctoral student in conducting seminars, colloquia, and discussion groups, or through other activities in the pedagogical process. He/she thus acquires skills to manage work teams and to moderate discussions or tasks within them. Two courses provide support to these activities of the doctoral students: Academic Writing for Doctoral Students (A. Vydra) and Adequate Scientific Practice (J. Vydrová).

## The aim of the doctoral study program

The doctoral study is planned as an open space for the independent and creative activity of the doctoral student in fulfilling his own research goals and acquiring scientific research skills and

## 8. Spatial, Material, and Technical Provision of the Study Programme and Support

- two seminar rooms with a capacity of 24 seats,
- if the capacity utilization of the courses requires it, we also have a room with a capacity of 54 seats, or other rooms available at the Faculty of Arts of Trnava University,
- technology parks, technology incubators, school enterprises, practice one room set aside for doctoral seminars, consultations, and teaching of foreign students during exchange stays.

All these rooms have both traditional and modern material and technological equipment, which includes whiteboards, data projectors, laptops or desktops with internet connection and intranet services (online catalogs, library systems, etc.), as well as technologies designed for the projection of presentations, videos, or recordings related to teaching.

Two of the seminar rooms also serve as libraries, where teachers and students have access to classical and contemporary study literature in the fields of philosophy, humanities, and cognitive sciences. The department administrator of this library is Mgr. Milan Petkanic, Ph.D. (milan.petkanic@truni.sk). Each of the teachers uses their desktop or laptop with a connection to a high-speed black and white or color printer. The department also has multifunctional devices, copiers, and scanners. Students have access to photocopiers and computers for guick access to information, located in the hallways of the faculty.

For students, there is also a study room at the University Library of TU and in their free time, there are spaces with loungers for relaxation or independent study. Students can also use: Swimming pool Zátvor, the gymnasium of the Secondary Vocational School OS, climbing wall BouldroFka, the gymnasium at the Student Home of Peter Pázmaň. Characteristics of the study programme information management. The information provision of the Philosophy study program is based on ensuring the accessibility of

- through University Library of Trnava University,

- through a network of journal and article databases,
- through using e-learning information technologies.

The University Library provides students and teachers with absentee and full-time loans of books, final theses, and scholarly periodicals, which are available to them within the University Library study room in the case of full-time loans. Students and teachers use the DAWINCI university information system to search for resources, which also includes an online catalog, which enables easy and fast localization of the required literature. At the same time, users have accessible manuals on the online catalog page, which provide them with ways to search for literature clearly and understandably. The University Library also provides the Interlibrary Loan Service (ILL) and the International Interlibrary Loan Service (ILLS).

Students can also loan suitable study literature from the Library of the Department of Philosophy, Faculty of Arts, Trnava University, which is a special location within the University Library of TU. This library specializes in publications and books in the fields of philosophy, humanities, and cognitive sciences and provides students with literature for full-time loans and study. Individual titles can be searched within the online catalog of the DAWINCI university system. The department administrator of this library is Mgr. Milan Petkanic, Ph.D. (milan.petkanic@truni.sk).

The university library also provides remote access to information resources via the RemoteApp application.

A key part of making information available is the use of the e-learning systems MS-Teams and <u>LMS Moodle</u>, where teachers provide students with study texts and literature for study purposes.

The doctoral study program Philosophy for internal study is prepared mainly in the full-time teaching process, but also presupposes the possibilities of distance or e-learning education, either due to unpredictable social circumstances, such as a pandemic situation or in justified cases as a result of an individual study plan, for which the consent of the dean of the faculty is required.

At Trnava University, the Information Systems Center (CIS) is available to students and teachers as an independent information and development workplace, which ensures and coordinates the development, operation, and effective use of information and communication technologies. The CIS participates in the support of educational, pedagogical, scientific-research, management, and information activities at the university.

The university uses central information systems to implement modern forms of the teaching process: in particular the Modular Academic Information System MAIS and MS Teams. MS Teams enables online lectures, conferences, consultations, lecture recordings, material sharing, individual and group communication, submission of assignments or tests via the Forms application, and their evaluation by teachers. It is used as a suitable tool for distance or e-learning education. Educational content and assigned tasks can be published online as well as shared on the LMS Moodle platform. It is also a suitable and secure e-learning tool. Students will find materials, lectures, resources for individual courses. From 1 August 2021, the LMS Moodle system was updated to version 3.9.7 and integrated

with MS Office 365. This ensured the synchronization of the MS Teams and LMS Moodle. This feature allows automatic team creation for LMS Moodle courses, automatic synchronization of LMS Moodle course participants with team members, automatic creation of LMS Moodle bookmarks on the general channel of the created team with a link to the LMS Moodle course page.

LMS Moodle is also integrated with the NetIQ IDM identity management system and the modular MAIS academic information system. This integration provides automated access to the LMS Moodle system for authorized users (teachers and students) and automated creation of courses from MAIS subjects and assignment of lecturers (teachers) and participants (students) to courses, based on data on teachers assigned to subjects and students who have the given subjects enrolled in the study plan.

MS OneDrive is a suitable tool for personal cloud storage with a capacity of 1 TB, with which you can access your files from any device.

The University has the right to provide its students, teachers, and staff with access and open licenses to use Office 365 ProPlus.

Trnava University provides its staff and students with remote access to <u>information resources</u> and <u>databases</u> available on the University Library website. Access is possible via RemoteApp (Google Chrome, Mozilla Firefox, Internet Explorer and Microsoft Edge).

In the necessary transition to online education, students have information and instructions on how to proceed and use the possibilities of remote access and online teaching. There is also a study advisor and MAIS department coordinator, Mgr. Milan Petkanič, Ph.D. (milan.petkanic@truni.sk). During e-learning, teachers automatically create teams in LMS Moodle and MS Teams, which allows a smooth and seamless transition to distance learning, if necessary.

Institution partners in providing educational activities for the study programme and the characteristics of their participation

The Department of Philosophy of the Faculty of Arts of Trnava University does not have external partnerships defined in its study programs outside university workplaces, but cooperation with some scientific or cultural institutions is reflected in the educational process within above-standard activities for students. Examples of such institutions are:

- Institute of Philosophy of the Slovak Academy of Sciences invited individual lectures
- Ján Palárik Theater in Trnava excursions within courses on aesthetics and interpretation of works of art
- Little Berlin (Nádvorie, Trnava) cooperation in organizing philosophical discussions during the Night of Philosophy with the participation of students of the Department of Philosophy.

Characteristics of the possibilities for social, sports, cultural, spiritual, Trnava University provides students with a wide range of opportunities for sports activities, such as football, volleyball, basketball, futsal, floorball, or swimming. The university coordinator for sports is Ing. Jozef Koricina (jozef.koricina@truni.sk).

> Since 2004, he has been organizing Sports Days, the aim of which is the competition of students and employees of individual parts of the university.

Traditionally, there are competitions in basketball, volleyball, and futsal for the traveling rector's cups of TU and table tennis tournaments for the master of the university. The best athletes from these competitions represent the university at the Universides of the Slovak Republic or other occasional competitions of Slovak universities.

In addition, students have the opportunity to sign up for various dance and aerobic classes. There are also current videos with exercises prepared for university students by students of the Faculty of Education: Truni, move!

Students can also use: Swimming pool Zátvor, the gymnasium of the Secondary Vocational School OS, climbing wall BouldroFka, the gymnasium of the Student Home of Peter Pázmaň. Students of the Department of Philosophy have been chess players for many years and also participate in national tournaments.

Students of the Department of Philosophy attend theater performances at the Ján Palárik Theater in Trnava, philosophical discussions, conferences or festivals individually or together in student circles or with teachers (for example Night of Philosophy, Epoch in Nové Zámky, summer philosophical symposium Agora 21 in Banská Štiavnica On their initiative and with the support of the Department of Philosophy, our students have been organizing the Hereditas student conference with international participation of students from other universities since 2014.

Trnava University builds on the tradition, spiritual values, and Christian culture of one of the oldest universities in Central Europe. It applies Christian-oriented university education and the development of science and research in the philosophical, human, and social sciences, and arts. Students can also benefit from spiritual counseling within the University Pastoral Center.

Within the Student Support Center, students can use several types of counseling: psychological counseling, support for students with special needs, legal counseling, career counseling. Students are also represented by the Student Council of Trnava University, which also aims to defend and

organize study, professional, social, sports, cultural and social interests, organizes chess tournaments, a literary club, a debate club, a climbing club, and a yoga club.

The university also provides full-time study for students with special needs creating suitable conditions for using the services of the Student Support Center, educating teachers, staff, and students to gain correct access to students with special needs, cooperation with students, faculty departments in connection with admission procedures for students with special needs, provision of priority accommodation for students with special needs in barrier-free areas, establishing contacts with other organizations that are helpful for the students, provision of compensatory aids (reading magnifiers, positioning chairs, hearing aids and other tools).

Possibilities and conditions for the participation of the study At the Department of Philosophy, we support student mobility within the Erasmus+ and CEEPUS programme students in mobilities and internships (indicating contact programs, and we also support individual student initiatives within the framework of mobilities, details), application instructions, rules for recognition of this courses, and internships within SAIA and the National Scholarship Program. The results of this education within the framework of cooperation schemes with partner universities are recognized by the university.

> All information regarding the possibility of travel, selection procedures are published on the faculty's website in the student information section or on the university's rector's website. Support for mobility programs and their use is provided to students by the External Relations and Cooperation Department and faculty coordinators.

> The Department of Philosophy has its coordinator for the CEEPUS program, doc. Jaroslava Vydrová (jaroslava.vydrova@truni.sk). We are part of a mobility program within two networks: 1) Philosophy and Interdisciplinarity, which involves 24 universities and three research institutes, and 2) Ethics and Politics in the European Context, in which 18 universities operate.

> Students can obtain credits from the offer of the host university (ECTS Label), access to libraries and archives, and, in addition to individual stays, they can also join summer schools. Teachers can also use the mobility for lecture stays. The interest in visiting our department grew despite the uncertain epidemiological situation - for the academic year 2021/2022, three lecture stays of teachers from abroad within the CEEPUS scheme are planned.

A supervisor is assigned to each of the listed topics. The applicant registers for one of the topics listed by the faculty. The faculty, in agreement with the guarantor of the relevant study program or the relevant department or institute, may also accept the topic proposed by the applicant. "  Transparency and a fair selection of candidates are guaranteed by a commission examination of the candidates' applications. Rector's Guidelines on Doctoral Studies in Art. 3, par. 6 to 10 stipulate the act of selection of candidates in the following way: The candidates are invited by the faculty to the admission examination no later than 14 days before the date of its holding, and the faculty at the same time announces the content focus of the admissions. The examination consists of a scholarly exam, including a scientific discussion on the chosen topic of the dissertation, while knowledge of a foreign language is also taken into account. The examination takes place in front of the admissions committee, which has at least three members and is appointed by the dean of the faculty. The committee will evaluate the result of the examination in private. In the case of several candidates, the commission determines the order of the candidates according to the exam result and also takes into account the scope of publishing and other professional activities, as well as the candidates' readiness to work with foreign scientific literature. A report is written on the result of the examination, which the committee submits to the dean of the faculty on the day of the examination. Further information on admission procedures can be found in the conditions for admission to doctoral studies. |

In the area of obtaining feedback on the teacher's pedagogical performance, one of the means at the university and its faculties is an anonymous questionnaire, mapping indicators of the quality of education, which allows obtaining feedback from the student. This provides an opportunity to further analyze the quality of the teacher's instruction, streamline the instruction and, in particular, improve the teacher's didactic and social competences to increase his own satisfaction with the educational process, as well as students' satisfaction with the quality of teaching.

Student feedback related to the effectiveness and availability of supporting material, technical and information resources is surveyed at all faculties primarily through a questionnaire to determine the quality of education. The results of student questionnaires of satisfaction and quality of the educational process are published twice a year on the website of the university, or its faculty.

Results of student feedback and related measures to improve the study programme quality

Based on questionnaires and surveys concerning the identification and improvement of the quality of educational processes at the Faculty of Arts of Trnava University, the faculty determines specific procedures for continuous improvement of the quality of university studies in the study programs it covers. They evaluate in accordance with <a href="the instruction of the Rector of TU no. 1/2014">the instruction of the Rector of TU no. 1/2014</a> on quality <a href="assurance in higher education at Trnava University">assurance in higher education at Trnava University</a> the satisfaction with the quality of teaching and material equipment, course surveys for the winter and summer semesters, graduate surveys, and graduate surveys two years after graduation.

These procedures are applied according to the standards developed in <a href="the-Internal Quality System document">the Internal Quality System document</a>. Through regular monitoring and internal evaluation of processes in the field of education, creative activities, and related activities and their quality with the involvement of the different parties and subsequent adoption of measures, Trnava University supports the development of higher education quality culture inside and outside the institution.
